Fund Description

The VanEck S&P/ASX MidCap ETF invests in a diversified portfolio of ASX-listed securities with the aim of providing investment returns (before management costs) that closely track the returns of the S&P/ASX MidCap 50 Index.

The S&P/ASX MidCap 50 represents the MidCap universe for Australia. The index is comprised of all the members of the S&P/ASX 100 excluding those in the S&P/ASX 50. Index constituents are drawn from eligible companies listed on the Australian Securities Exchange.

Prior to 26 July 2016 the fund operated under the name VanEck Australian Emerging Resources ETF and aimed to track the MVIS Australia Junior Energy & Mining Index (old investment objective). In the Blended Index, performance data from 26 July 2016 onwards reflects the fund's current investment objective, while performance data prior to 26 July 2016 reflects the old investment objective.
